(the “Company”) hereby announces that, as resolved at the meeting of the Board of Directors held on February 12, 2025, it implemented the repurchase of its treasury shares pursuant to Article 156 of the Companies Act, applied following the deemed replacement of terms pursuant to the provisions of Article 165, Paragraph 3 of the Act.
